_____ All applicants are required to get a background check @ applicant's expense

_____ Trainings are held every Tuesday night at 7pm @ Hematite Fire House 2 @ 3067 Meyer Rd. Festus, Mo 63028.

_____ All volunteers are required to attend at least 2 trainings before you are issued any gear or equipment that is property of Hematite Fire Protection District.

_____ New volunteers may be subject to a 365 day probationary period; there is no obligation for the district to keep the volunteer until the end of this period. The district has the right to terminate the volunteer without advance notice. The chief may also extend this time period at his discretion.

_____ Blue light permits will be issued at Chiefs discretion until this time no blue lights are to be displayed in vehicle or used.

_____ Anytime on fire scene or at firehouse no inappropriate clothing is to be worn, such as t-shirts with profanity on them.

_____ Drugs and alcohol are not to be used on fire department property and smoking is only allowed in designated areas.

_____ When volunteer leaves the department by choice or upon termination, all department property such as gear, pagers, radios, ect. Must be returned to the Chief.
